

**Terms and Conditions Applicable to
And Request for
Reproductions of Photographs or other Materials**

1. No reproduction of photographs or other archival materials may be made in any manner whatsoever without the Archives knowledge and consent.
The Archives retains all rights to the photographs in the Archives, including any reproduction of any such photograph.
2. Single copies of archival materials may be provided for purposes of research or private study. Use for other purpose may require authorization of the copyright owner. The client assumes full responsibility for locating the copyright owner and obtaining any necessary authorizations for use other than research.
3. Researchers / clients must accept responsibility for determining copyright obligations, and for securing any and all publication rights that may apply to any photograph or other material (including ensuring that no one's personality or privacy rights are violated in any such publication);
4. The use of any reproduction must be limited to the express purpose for which the reproduction was requested. All other uses are prohibited without the express written authorization of the Archives or the copyright owner
5. An appropriate credit line and acknowledgement of copyright must be given in all cases of publication, exhibition, presentation or other display of that reproduction.

Credits should appear in close proximity to the image or in a special section devoted to credits. Reproductions distributed electronically must contain the credit or caption as part of the image.
6. Any subsequent use (including subsequent editions, paperback, foreign language or electronic editions) constitutes re-use and must be applied for in writing to the Minnedosa Regional Archives and will be subject to additional usage fee. However, the applicant may use the image on packaging or in any advertisement, catalogues, publicity or promotional use, solely in connection with marketing and distribution of the product.
7. Unless authorized in writing by the Archives and noted in the credit line, no reproduction will be shown with added colouring, will be superimposed or transposed, or will be modified, altered or cropped in any manner whatsoever that significantly changes the meaning or context of the image, or that compromises its authenticity as an historical document.
8. Any reproduction of a photograph must be destroyed upon conclusion of the project in respect of which the reproduction was made, unless that reproduction was made with the Archives knowledge that it would not be destroyed and with payment of the appropriate fees to the Archives.
9. The Minnedosa Regional Archives reserves the right to demand that any reproduction of any archival material including photographs in the holdings of the Archives be returned in the event of an actual or a threatened breach of this Policy.
